Model NNFEBFPG shall retrofit to existing OASIS PG* AC and P* AC series water coolers to provide contactless activation. Retrofits to both single and split level models. Model NNFEBFPG shall include the VersaFilter® Sports Bottle Filler. Key VersaFilter components contain Freshield®, which utilizes a silver-based antimicrobial compound to protect the surfaces from discoloration, odors and degradation caused by the growth of micro-organisms and mildew.
